3. Length of the hose is approx. 345 meter with a towing speed of 5 knots up to 8 knots. All moving vessels within close vicinity shall keep at least **100 meters** away from the sliding zone of this hose.

4. **Mike Kilo** (Bintulu Port control tower) has the right to stop this activity without any prior notice in advance to protect the port operation.

5. Vessel involved shall alert nearby vessels coming close proximity during this campaign and also be reminded to activate her AIS system continuously.
