NOTICE TO CONDUCT NEARSHORE PRE-TRENCHING & PIPELINE INSTALLATION WORK WITHIN BINTULU PORT WATER LIMIT FOR PETROS SAMALAJU PIPELINE PROJECT

1. **TAKE NOTE** that the above campaign will commence work from **22 May until 31 August 2025**.
2. Please be informed that the above activity will be conducted with the following particulars:

4. Therefore, all vessels are advised to keep clear the area for vessel involved in this activity at a **distance off 100m**.
5. **Mike Kilo** (Bintulu Port control tower) has the right to stop this activity without any prior notice to protect the port operation. Additionally, the following weather limitations will apply to the stop work order:
- 5.1 Wind speed: **18 knots**
- 5.2 Swell height: **1.0 m**
6. The vessel involved shall alert nearby vessels coming in close proximity during this campaign and also be reminded to activate her AIS system continuously.
7. Any movement of vessel within the Bintulu Port water limit shall be reported to **Mike Kilo** at channel 12.

8. For any case of emergency, please refer to the Emergency Response Procedure. **Mike Kilo** shall be informed immediately at channel 12.
